The University Grants Commission vide letter read as 2 above has informed the Registrar of the University that the Commission at its meeting held on 20.09.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to Nehru College of Engineering and Research Centre, Nila Gardens, Pampady, Thiruvilwamala, Thrissur, Kerala, India – 680 588 affiliated to APJ Abdul Kalam Technological University, Kerala, as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 affiliated to APJ Abdul Kalam Technological University, Kerala, for a period of Ten (10) years from the Academic Year 2023-2024 to 2032-2033 and requested the University to issue Notification/Order as per UGC Regulations referred (1) above. The Government as per reference (3) above, has directed the University to take necessary steps to issue notification/order regarding the grant of autonomous status to the colleges as per UGC Regulations, 2023.

2. The 55th Syndicate meeting of the University held on 18.03.2024 vide item no. S-S-55-018 after having considered the communication of the University Grants Commission and Government referred (2) and (3) above, the UGC Regulations referred (1) above and the provisions of the APJ Abdul Kalam Technological University Act, 2015, and the Statutes,



Ordinances, and Regulations made thereunder, resolved to issue notification for the conferment of autonomous status to Nehru College of Engineering and Research Centre, Nila Gardens, Pampady, Thiruvilwamala, Thrissur, Kerala, India – 680 588 (which shall all form part of this notification as if incorporated herein).

NOW THEREFORE, IN ACCORDANCE WITH AND SUBJECT TO CLAUSES 1 AND 2 ABOVE, THE APJ ABDUL KALAM TECHNOLOGICAL UNIVERSITY HEREBY NOTIFIES NEHRU COLLEGE OF ENGINEERING AND RESEARCH CENTRE, NILA GARDENS, PAMPADY, THIRUVILWAMALA, THRISSUR, KERALA, INDIA – 680 588 AS AN AUTONOMOUS COLLEGE AFFILIATED TO THE UNIVERSITY FROM 20.09.2023 FOR A PERIOD OF TEN YEARS (ACADEMIC YEAR 2023-2024 to ACADEMIC YEAR 2032-2033) AS PER CLAUSE 7.5 OF THE UGC REGULATIONS,2023.
